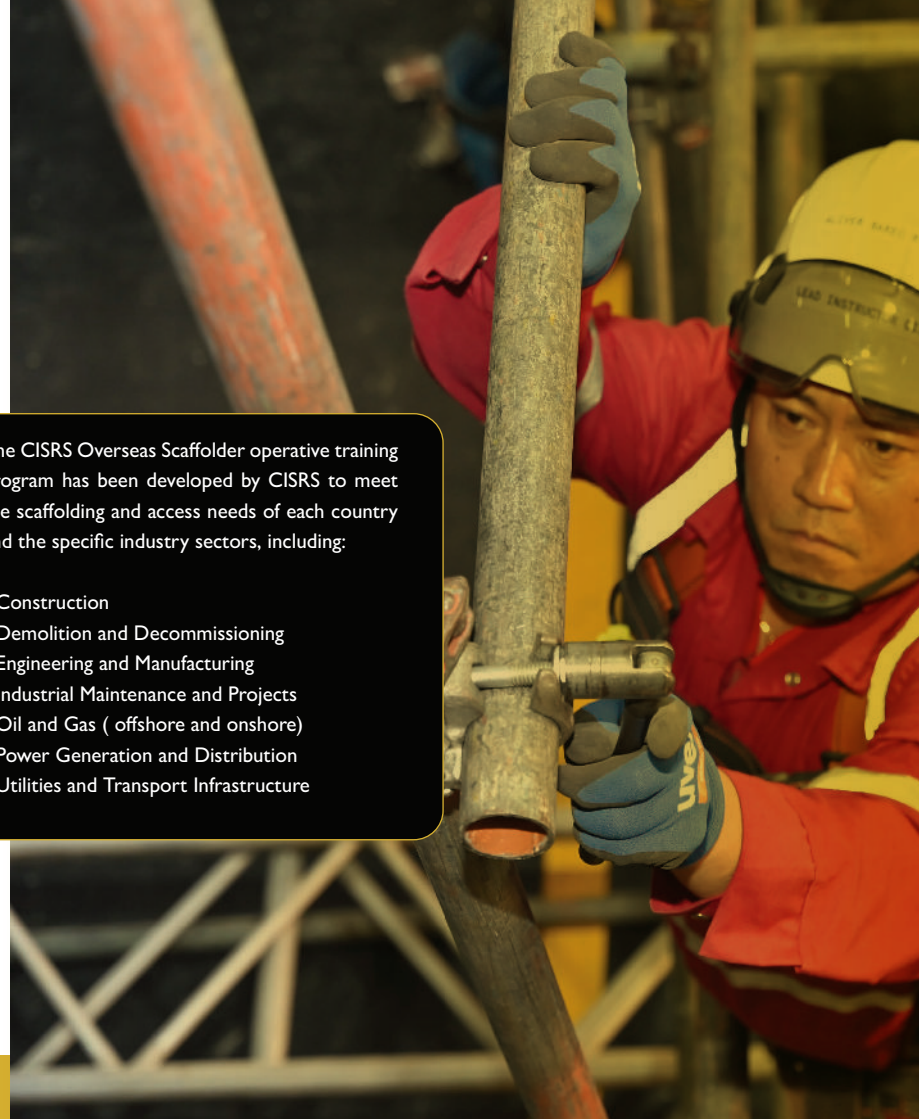
It is one of the oldest trade card schemes in existence and is now available outside of the UK. The scheme is often wrongly referred to as the CITB scheme, whereas CISRS was originally introduced in the late 1960's but training began in earnest after 1979 following the development of formal courses in the UK. Since then tens of thousands of Scaffolders have undertaken CISRS training and it has become recognised as best practice for quality accredited training around the globe.

This Overseas Scaffolder training scheme was introduced to meet the needs of industry for employers who recognise that Scaffolder competence is key to providing and maintaining safe scaffolding.

The new Overseas Scaffolder Training Scheme (OSTS) launched January 2013, has been specifically designed to meet the needs of Scaffolders globally and is only available through carefully selected Approved CISRS Training Providers, such as Simian International.

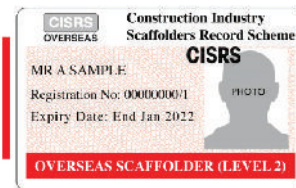

Progression Chart



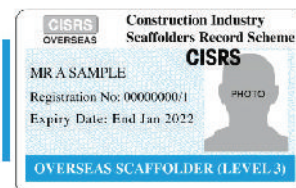

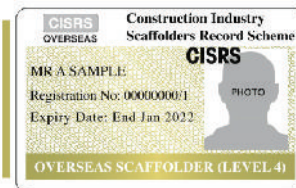
